



MEASURES FOR THE CONTRAST AND CONTAINMENT OF DIFFUSION OF THE COVID 19 VIRUS

The entrance to the Camping Village Duca Amedeo constitutes the unreserved acceptance of the present Regulations with particular attention to the use of the mask in closed places such as reception, bar, restaurant, toilets access to the beach, access to the pool, access to the amphitheater and in any case outdoors where the spacing of at least one meter is not guaranteed. The contents of Ordinance 70 Section 5 of 07/06/2020 of the President of the Abruzzo Region are reported.

HYGIENIC-SANITARY BEHAVIORS TO BE ADOPTED BY THE GUESTS

Customers must comply with the following obligations:

- A. Obligation not to access the tourist accommodation area in the event of a quarantine provision, in the presence of flu symptoms or with a body temperature above 37.5 ° C, or if you come from areas of epidemic outbreaks reported by the Ministry of Health;
- B. obligation of social distancing of at least one meter, during each stay and activity within the accommodation facility;
- C. respect for social distancing in all circumstances, including when using showers and toilets;
- D. frequent washing of the sheets, at least at 60 ° C;
- E. Personal hygiene measures, especially taking care of frequent cleaning and disinfection of hands also some children;
- F. obligation to shower immediately after bathing with particular care for cleaning hands and face;
- G. wear surgical masks according to the legislation in force;
- H. control by the parents of the respect of all behavioral norms by the children.

Exceptions to physical distancing are limited to people belonging to the same family unit or cohabiting (for this purpose, it is possible to acquire a specific self-certification).

REGISTRATION

Upon arrival, the group leader (holder of the reservation) must go to the Reception alone and access it when you see your turn and put on the mask to confirm check-in with your identity document, sign the privacy document and of the self-declaration referring to the shared regulatory protocol of measures to combat and contain diffusion of the Covid-19 virus.

VISITORS

It is strictly forbidden to extend invitations and even temporarily host people.

BEACH

For hygienic purposes, empty seats or seats assigned by the management to other customers cannot be used. In order to facilitate distancing, the routes to reach your entrance and exit umbrella must be respected indicated by the signs installed on the beach.

In the toilets, although they are clean and sanitized several times a day, we recommend the use of a hand shower or alcoholic gel made available to disinfect the tablet and wash your hands well. It is mandatory to use your own towel on the cot.

POOL

In addition to the swimming pool regulations used in past years, the use of your own towel on the sun bed is mandatory. Out of respect for the density of crowding both in the pool and in the solarium area, the staff will be able to limit access.

In particular, the contents of Ordinance 70 Section 16 of 07/06/2020 of the President of the Abruzzo Region are reported.

Observe the usual hygiene safety rules in swimming pool water:

A. before entering the bath water, take a thorough soapy shower all over the body; the use of a swimming cap is mandatory;

B. it is forbidden to spit, blow your nose, urinate in water;

C. to very young children to wear the containment diapers;

For the disinfection of the loungers the pool will be closed during the lunch break.

In the toilets in the pool, although they are cleaned and sanitized several times a day, we recommend before and after using a shower or some alcoholic gel made available to disinfect the tablet and wash your hands well

TOILET

The group of toilets can only be used by guests staying on the pitch. Guests of the village area can use only the laundry area. In the toilets although they are cleaned and sanitized several times a day, we recommend the use of a hand shower or the alcoholic gel made available to disinfect the tablet and to wash your hands well.

PLAYGROUND

Children must be under the supervision of a parent. The playground will have limited hours in the presence of an assistant and to allow the necessary disinfection operations. To respect the crowding density, the staff may limit access.

CAMPING

The mobile vehicles of customers (campers, caravans, tents) must be positioned equidistant from the edges of the pitches. To ensure compliance with the distancing measures between the various crews, they must be separated from each other by a free band of at least 2 meters (they must respect each other the distance of 1 meter for the entire perimeter), where it is not possible to respect such distances it is mandatory to install a tarpaulin on the boundary of the pitch with a protective barrier function.
